Buyer shall, either approve the drawings or will provide complete list of modification required in the drawings within 10 days. Seller shall be required to ensure supply as per approved Drawings with modifications as communicated by Buyer. If there is delay from buyer side in approval of drawing- the delivery period shall be refixed without LD for the period of delay in approval of Drawing.
- Actual delivery (and Installation & Commissioning (if covered in scope of supply)) is to be done at following address ICAR-National Research Centre for Integrated Pest Management, LBS Building, IARI, Pusa Campus Delhi, New Delhi-110012.
- Scope of supply (Bid price to include all cost components) : Only supply of Goods
